- You have also forged many relationships with organisations and charities, including our very one 'Keep Britain Tidy' campaign, and these are great examples of collaboration. We'll need this approach to fight the impacts of climate change in the future! It is heartening to read that your hard work is obviously paying off because more people are taking an interest and want to be involved in your Eco-Schools work.
